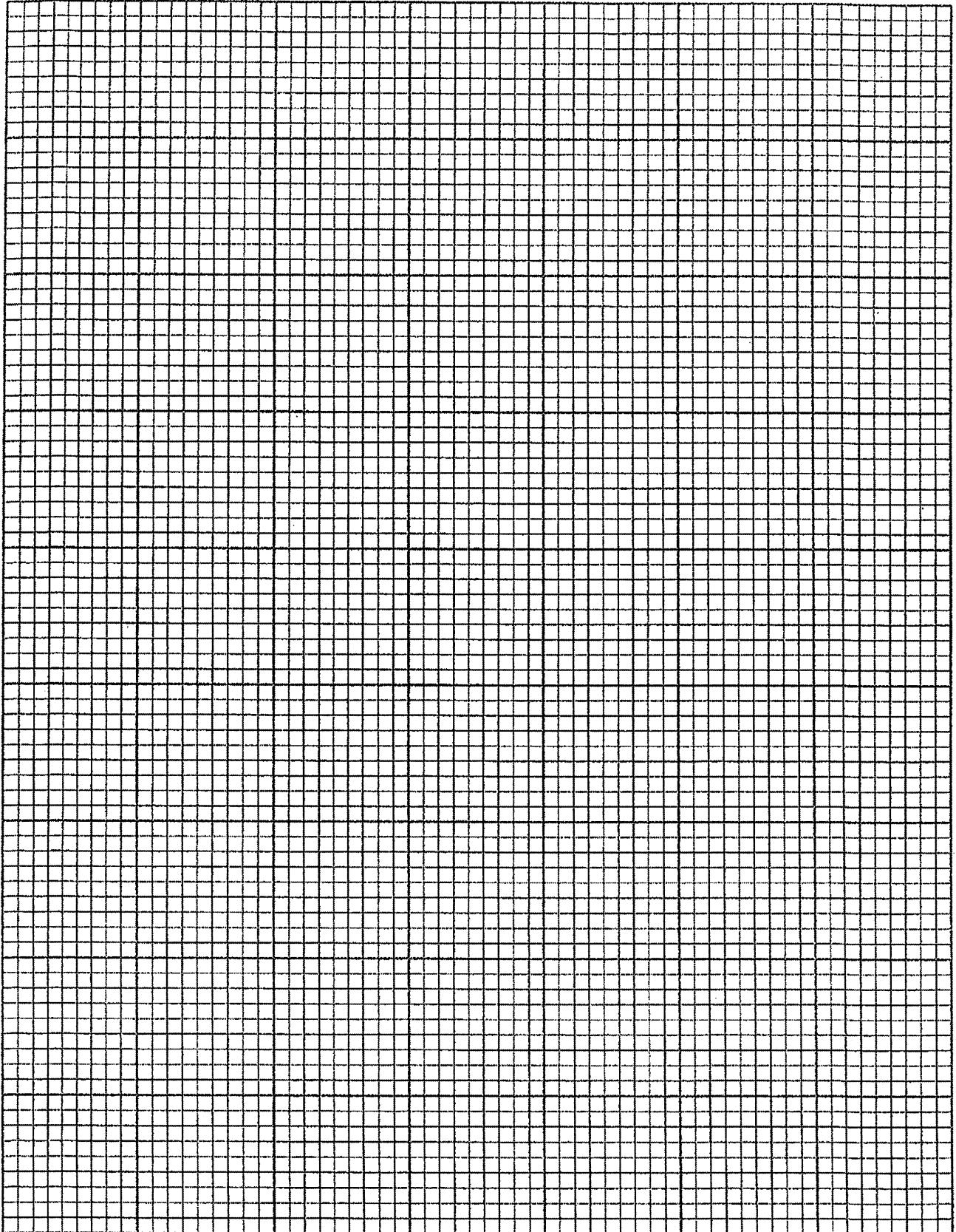

The permit application for the temporary sale of cut Christmas trees and accessories can be conducted with the following conditions:

- 1. Completed and signed Seasonal Sales application.**
- 2. Plot plan.**
- 3. Permit fee \$100.00 and Escrow fee \$100.00**
- 4. Signed copy of lease agreement between property owner and tenant.**
- 5. No off premises signs are permitted.**
- 6. No open burning is permitted.**
- 7. No tents are permitted without prior approval by the Township**
- 8. All strung light bulbs shall be shielded and protected from breakage.**
- 9. A minimum of 10 feet clearance shall be maintained from the property lines, buildings, gas pumps and parked cars.**
- 10. Cut debris shall be removed on a daily basis; not allowed to accumulate.**
- 11. \$100.00 Escrow Deposit returned after final inspection of cleared parcel.**

Failure to abide by these conditions may result in the facility being shut down, your license revoked and citations filed in district court.
