#### Ridley Township Board of Commissioners January 22, 2025 Meeting Minutes

The Regular Meeting of the Ridley Township Board of Commissioners was called to order by Board President Willert at 6:00pm on January 22, 2025 at the Township Building.

The following Commissioners were present: Mr. Saraceni, Mrs. Morrisette, Mrs. Cummins, Mr. McMenamin, Mr. Saunders, Mr. Warwick, Mr. Willert, Mr. Capozzoli and Mr. Bidoli.

Also present were Mr. Ryan (Township Manager), Mr. Betzler (Township Controller), Mr. Catania (Township Engineer) and Mr. Neill (Township Solicitor).

The Pledge of Allegiance was recited.

#### **Executive Session Announcement**

Mr. Willert announced the Board met in an executive session on January 14, 2025 to interview the three candidates for the position of  $8^{th}$  Ward Commissioner.

Mr. Willert nominated Michael D. Capozzoli to fill the vacancy of 8<sup>th</sup> Ward Commissioner. No other nominations were received.

Motion made by Mr. McMenamin, seconded by Mrs. Cummins to appoint Michael D. Capozzoli as 8<sup>th</sup> Ward Commissioner. Motion carried unanimously (8-0).

A Resolution was presented appointing Mr. Capozzoli.

Motion made by Mr. McMenamin, seconded by Mrs. Cummins to adopt the Resolution as presented. Motion carried unanimously (8-0).

Mr. Willert read Mr. Capozzoli's background and welcomed him to the Board. The Honorable Jack Whelan swore Mr. Capozzoli in as 8<sup>th</sup> Ward Commissioner.

## **Presentation to Officer Sara Howell**

The Board presented Officer Sara Howell a Certificate of Commendation for her heroic actions at an accident involving a CSX train and vehicle on December 18, 2024. Senator Kearney and State Representative Dave Delloso also presented Officer Howell with official recognitions from the State of PA.

## Manager's Report

Mr. Ryan updated the Board on Portnoff Law Associates' efforts in collecting delinquent taxes and rubbish and sewer charges. Over the 3-year period they have been engaged, over \$600,000 in delinquencies have been collected.

Mr. Ryan announced Folsom Fire Company's intent to host an Italian Festival on March 29, 2025 at the firehouse and are requesting permission to close 4<sup>th</sup> Avenue from Tasker to Sutton and also close Sutton Ave from 4<sup>th</sup> to Orchard.

Motion made by Mrs. Cummins, seconded by Mr. Bidoli to approve the request as presented. Motion carried unanimously (9-0).

Mr. Ryan requested approval to award the bid to dispose of a 2012 Dodge Charge in the amount of \$2,600 through the Municibid website.

Motion made by Mrs. Morrisette, seconded by Mr. Warwick to approve the award as presented. Motion carried unanimously (9-0).

#### **Recycling Report**

Mr. Bidoli reported trash collected in December was 1,771.08 tons and recycling collected in December was 177.08 tons. 4 televisions were collected in December.

Motion carried unanimously (9-0). Mr. Catania recommended award of a COSTAR proposal from Musco in the amount of \$386,804.00 for an LED lighting system on the baseball and softball fields at Blackrock Park. A state grant was received for these Phase 3 improvements at the park. **Motion made by Mrs. Cummins, seconded by Mrs. Morrisette to approve the award as presented. Motion carried unanimously (9-0).** 

Mr. Catania requested authorization to advertise for bids for the Blackrock Park ADA accessibility improvements.

Motion made by Mrs. Morrisette, seconded by Mr. Bidoli to approve the request as presented. Motion carried unanimously (9-0).

Mr. Catania requested approval of the 2025 County Aid resolution for the road resurfacing program in the amount of \$32,994.00.

Motion made by Mr. Saunders, seconded by Mr. Saraceni to adopt the resolution as presented. Motion carried unanimously (9-0).
