Ridley Township Board of Commissioners June 28, 2023 Meeting Minutes

The Regular Meeting of the Ridley Township Board of Commissioners was called to order by President Willert at 6:00pm on June 28, 2023 at the Township Building.

The following Commissioners were present: Mr. Saraceni, Mrs. Cummins, Mr. McMenamin, Mr. Warwick, Mr. Willert, Mrs. Melasecca and Mr. Bidoli.

Also present were Mr. Ryan (Township Manager), Mr. Catania (Township Engineer), Mr. Betzler (Controller) and Mr. Neill (Township Solicitor).

The Pledge of Allegiance was recited.

Mr. Willert addressed the issue of racist documents circulating in some neighborhoods and the actions taken by the Commissioners and Police upon the discovery. He assured residents that the Board does not tolerate the actions of those who circulated the materials and that the police are actively investigating the matter.

Mr. Willert thanked the police, fire and highway departments for their work during the recent storms.

Mr. Willert sent the Board's condolences to the family of Dan Long who worked in our Traffic Maintenance Department.

Public Forum

Ray Bunting, 529 Ridley Avenue, Mark Bryan, 525 Ridley Avenue and Jamie Hills, 527 Ridley Avenue appeared before the Board concerning flooding in their backyard. The Board replied the drainage improvement project is out to bid, but the township is still waiting on some easements before the work can begin.

Vera D'Ercole, 2439 Secane Road, Secane, appeared before the Board concerning water along Secane Road.

Jen Ferdunh, 127 Randall Avenue appeared before the Board concerning short-term rental regulations.

Approval of Minutes

Motion made by Mrs. Cummins, seconded by Mr. Bidoli to approve the March 22, 2023 and April 26, 2023 meeting minutes. Motion carried unanimously (7-0)

Manager's Report

Mr. Ryan requested approval of Notre Dame de Lourdes Carnival request for September 28th through September 30th.

Motion made by Mrs. Cummins, seconded by Mr. Saraceni to approve the carnival request as presented. Motion carried unanimously (7-0).

Mr. Ryan requested approval of a Resolution increasing the commercial trash hauler's fee from \$50.00 to \$200.00. Mr. Willert asked if we can add that their permit will be revoked if they are in violation of the noise ordinance. Mr. Ryan suggested tabling the Resolution to add that provision.

Motion made by Mr. Willert, seconded by Mr. Saraceni to table action on the Resolution. Motion carried unanimously (7-0).

Recycling Report

Mrs. Melasecca reported trash collected in May was 1,317.08 tons and recycling collected in May was 159.79 tons. 3 televisions were collected in May.

Mr. Neill reported the request for an Intermunicipal Liquor License Transfer to the property located 2171 MacDade Boulevard has been withdrawn by the applicant.

Mr. Catania reported the PennDOT South Ave Resurfacing Project was awarded to Alan Myers and is expected to begin over the summer.
